SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW: Keep out of reach of children. Avoid eye contact. If in eyes: Immediately rinse with water. Wear protective gloves. This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use.

POTENTIAL HEALTH EFFECTS:

Aqua, Cetyl Alcohol, Sodium Malate, Isopropyl Myristate, Polyquaternium-37, Cetrimonium Chloride, Paraffinum Liquidum, Cetareth-25, Coco-Glucoside, Guar Hydroxypropyltrimonium Chloride, Citric Acid, Propylene Glycol Dicaprylate/Dicaprate, Sorbitan Oleate, Tocopherol, Hydrogenated Palm Glycerides Citrate, Acrylates/ Stearyl Methacrylate Copolymer, Glyceryl Oleate, Behentrimonium Chloride, Phenoxyethanol, Isopropyl Alcohol, Amodimethicone, Trideceth-12, Ethylhexylglycerin, Sodium Hydroxide, PPG-1 Trideceth-6, Sodium Benzoate, Disodium EDTA

SECTION 4 - FIRST AID MEASURES
